The Anvil

The Anvil, on the other hand, has a symbolic and a historical meaning which must be noted by all who call themselves African Methodist. OUR beginnings emerged from the depths of racism and bigotry and when our founding fathers chose to stay with Methodism they purchased a blacksmith's shop and converted it into their house of worship; they called it BETHEL, meaning "House of God."

In the blacksmith's shop was an anvil used to pound and shape metal ores into a usable and functioning object. And, as any blacksmith will tell you, hammers may wear down, and many a man may loose his life to the exhaustion from the hard work of being a blacksmith, but the Anvil never fails. A man only need to purchase one in his or her entire lifetime, and it continues to last through MANY lifetimes. So it is with God; He cannot be beaten down and He is Eternal. The Anvil represents our beginning and the lasting Strength of our Lord and Savior that never ceases.


**AFRICAN-** Our church was organized by people of African descent and heritage.

## THE AFRICAN METHODIST EPISCOPAL CHURCH

In 1794 the black Methodist of Philadelphia had raised enough money to build their own church.

However, most of the members decided to side with the Episcopalians instead of the Methodists.

They named that church St. Thomas African Episcopal Church. Allen disagreed with their decision and bought a blacksmith shop and converted it to a storefront church.

Methodist Bishop Frances Asbury named it "Bethel African Methodist Episcopal Church."

## THE AFRICAN METHODIST EPISCOPAL CHURCH



- The African Methodist Episcopal Church was founded by the Rev. Richard Allen in Philadelphia, Pennsylvania in 1816
- In April of 1816 the black Methodists of five congregations met at Bethel in Philadelphia and voted to organize under the name African Methodist Episcopal Church or AME Church.
- Richard Allen became the first bishop after Daniel Coker declined.






## OUR BELIEFS APOSTLE'S CREED

#### THE COMMISSION STRUCTURE OF LOCAL A.M.E. CHURCH

The **Pastor shall be the chairperson** of the Commission on Stewardship and Finance and the ex-officio chairperson on the other commissions.

The chairperson of each commission shall be a **steward** and therefore a member of the **Official Board and Quarterly Conference** to which <u>he or she is amenable</u>, with the exception of the Commission on Missions and Welfare, whose **chairperson may be either a steward or a trustee.** 

They shall make monthly reports to the Official Board and also quarterly reports to the Quarterly Conference.

The members shall be **elected by the church conference**, except that of the Commission on Christian Education.



# What Every Christian Ought To Know

**Christians Must Seek First God's Kingdom (Church) and Righteousness** 

Matthew 6:33

## WHAT IS STEWARDSHIP?

A Biblical definition of stewardship is "having dominion over the works of God." The works of God's hands includes all the material things and creatures of the Earth. We as stewards are not the owners of these things, but we are the stewards who have dominion of these things. Psalm 8:6 advises us of God giving us dominion over his works and creation.

Psalm 8:6, "Thou madest him to have dominion over the works of thy hands; thou has put all things under his feet;"

## STEWARDS OF TIME, TEMPLE, TALENT, AND TREASURE

• Time – Redeeming the Time That God Has Given You. God has given us our life and our time to manage as part of us being his steward. As good stewards, he expects us to manage our time, our life, according to his will. We are to redeem the time that God has provided us. Ephesians 5:16 advises us to redeem our time for God's glory.

Ephesians 5:16, "Redeeming the time, because the days are evil."

## STEWARDS OF TIME, TEMPLE, TALENT, AND TREASURE

**Temple – Care For Your Body, the Temple of the Holy Ghost.** The definition of stewardship includes caring for all things that God has given us. This includes our bodies. As Christians, our bodies are the temples of the Holy Ghost. If our bodies are to be temples of the Holy Ghost, then it goes without saying that we should not defile our bodies with sin. Ist Corinthians 6:19 advises us that our bodies are the not ours, but the temple of the Holy Ghost.

<u>Ist Corinthians 6:19</u>, "What? know ye not that your body is the temple of the Holy Ghost which is in you, which ye have of God, and ye are not your own?"

## STEWARDS OF TIME, TEMPLE, TALENT, AND TREASURE

**Talents – Use Our Given Talents For Good Works.** The definition of stewardship also includes the making use of the talents and abilities that God had given us. God has given each us unique talents and he desires us to put our talents to good use. As Christians, we can even say that God has ordained us with our unique talents to do his good works.

<u>Ephesians 2:10,</u> "For we are his workmanship, created in Christ Jesus unto good works, which God hath before ordained that we should walk in them."

#### STEWARDS OF TIME, TEMPLE, TALENT, AND TREASURE

**Treasure – Being Accountable For God's Treasure.** A key definition of stewardship is being accountable for God's treasures. The Bible tells us that all things are created by God and all things are God's. As God's chosen representatives, his stewards, God has given us material things to faithfully administer for his glory.

Haggai 2:8, "The silver is mine, and the gold is mine, saith the Lord of hosts."

#### LOCAL CHURCHES EXIST SPECIFICALLY TO PROVIDE TIMES FOR MEMBERS TO LEARN AND TEACH.

- When the church provides these opportunities, all the members ought to attend and participate in the teaching and learning.
- I Timothy 3:15 The church is pillar and ground of the truth.
- I Corinthians 14:19,26,31,40 The church conducts assemblies to teach and edify the members.
- Ephesians 4:15, 16 Each member must work to build up the body. This is true of *all* members and all church meetings. If all the members were as active as you are, how effectively would the church be built up?

#### CHRISTIANS SHOULD... BE GOOD EXAMPLES

#### Worship and Praise God

We should attend worship assemblies, not only because God wants us to, but also because we want to. Matthew 22:37-38 teaches "The greatest command is to love God with all our heart, soul, and mind." We should love God above all because He sent His only begotten Son to die to save us from eternal torment and offer us eternal life (Romans 5:6-8; 1 John 4:8-10,19; John 3:16).

#### PRAY

"Do not be anxious about anything, but in everything, by prayer and petition, with thanksgiving, present your requests to God." –Philippians 4:6



#### CHRISTIANS SHOULD... BE GOOD EXAMPLES

Attend regularly - Worship, Church meetings, Sunday School and Bible Study

I Timothy 4:12 - Be examples to believers in word, manner of life, love, faith, and purity. You should attend the assemblies for your own benefit, but consider also the effect on others if you do or do not attend. Surely new members and weak members need all the teaching they can get. But such people often decide how often to come by observing other members.

If they imitate you, will their need for teaching be met? (Titus 2:7-8)

# **Kingdom Builders**

## **STEWARDS**

• Stewards are the **Pastor's cabinet.** You serve as the personal advisors to the pastor.

- The Stewards shall be subject to the bishops, elders, deacons, and travelling ministers of their church.
- Stewards must be committed to addressing the spiritual concerns of the church, but remember they have some temporal duties as well.
   Your primary duty is to the church.

## **STEWARDS**

- Stewards are expected to be **fair**, **clear-sighted**, **level-headed**, **and capable of exercising good judgment**.
- While you may not always agree with the Pastor, it is your responsibility to support his/her vision for the church.
  - Why? Remember, he's the Shepherd of the flock. The Bishop appointed the pastor, not you!

### WHAT DO STEWARDS DO?

- Stewards must work harmoniously with the Pastor. (Come now, and let us reason together, saith the LORD... Isaiah 1:18)
- Stewards must know the **appropriate** process and procedure for addressing concerns. REFER TO THE AME DISCIPLINE!
- Stewards must **pray**, not **p-r-e-y**. If you're striving to be God's steward, you MUST BE ABLE TO give <u>anyone</u> a spiritual boost.

### **STEWARDS MUST BE:**

- of solid piety, know and love the Word of God, the African Methodist Episcopal Church doctrine, and The Book of Discipline of the African Methodist Episcopal Church;
- (2) Fruitful and of good natural or acquired ability transact spiritual and temporal (financial) business of the church;
- (3) a member of the African Methodist Episcopal Church for at least two (2) years, except in the case of the establishment of a new congregation.

### ABOUT THE STEWARD BOARD...

- The pastor is the chairperson of the Steward Board and appoints Stewards to serve for **ONEYEAR**.
- There shall be no fewer than three (3) and no more than nineteen (19).
- The Pastor may appoint a chairperson, pro tem to act in his or her absence. All business conducted in his or her absence shall be subject to veto by the pastor.

#### ABOUT THE STEWARD BOARD...

 There shall be appointed a Junior Board of Stewards that shall function under the direction of the pastor and Senior Board of Stewards.

 There shall be a training course for perspective Stewards under the supervision of the Pastor and Senior Stewards.

 The pastor shall submit nominated Stewards to the Quarterly Conference, which shall confirm or reject them.

#### WHAT ARE THE DUTIES OF THE STEWARDS? (FINANCIAL STEWARDS)

- Stewards shall make an exact accounting of <u>all money</u> to include other provisions collected for the support of the Pastor.
- The steward board negotiates the full time salary of the Pastor.

\*\*The Pastor's negotiated salary and benefits package shall be commensurate with the **cost of living in the given geographical area** and the **ability of the local congregation.** \*\*

#### WHAT ARE THE DUTIES OF THE STEWARDS? (PASTOR'S CARE)

#### The following benefits apply to those Pastors who are **full-time servants**:

- I. Pension or retirement
- 2. Insurances: health, disability, professional liability, key person life insurance
- 3. Self-employment tax
- 4. Parsonage or housing allowance
- 5. Continuing education
- 6. (6) travel: connectional, Episcopal district, conference, inner parish, and all other related to official duties.
- 7. If a housing allowance is given, it is the Stewards' duty to negotiate a reasonable housing allowance with the pastor.
- 8. They shall make accurate reports of every expenditure of money, whether to the Pastor, church, sick or poor.
- 9. They shall attend the Quarterly Conference to give advice, if asked, in planning for the church.

#### WHAT ARE THE DUTIES OF STEWARDS? (STEWARDSHIP)

- They shall <u>attend committee meeting</u> for disbursing of money to churches and give counsel in matters of arbitration.
- Seek the needy and distressed in order to relieve and comfort them.
- They shall write circular letters to societies of a circuit to let them know the state of temporal concern at the last Quarterly meeting and urge them to give more liberally.
- Stewards shall register all baptisms, marriages and deaths within the congregation.
- Stewards shall provide the implements and elements of Holy Communion.

# Does your church have an UP-TO-DATE MEMBERSHIP RECORD?

#### WHAT ARE THE DUTIES OF STEWARDS? (MEMBERSHIP)

- Each local church shall have its Steward Board conduct a survey of the membership during the **Third Quarter** with the purpose of determining to what extent each member of the church has supported the church financially, attended the regular means of grace, and supported the various benevolent enterprises of the church.
- The survey conducted by the Stewards shall contain date, name and address, date of birth, active, inactive, probation, student, left with certificate, left without certificate, deceased and class number.
- The Steward Board shall investigate all members on the roll and submit its findings to the Official Board for approval. The Certified Membership Roll shall be forwarded to the Fourth Quarterly Conference for submittal to the Annual conference. Each Annual conference shall forward all Certified Membership Rolls to the General Church Secretary (See AME Church Website for contact)

#### WHAT ARE THE DUTIES OF STEWARDS? (MEMBERSHIP)

 The Steward Board shall investigate all members on the roll and submit its findings to the Official Board for approval. The Certified Membership Roll shall be forwarded to the Fourth Quarterly Conference for submittal to the Annual conference. Each Annual conference shall forward all Certified Membership Rolls to the General Church Secretary (See AME Church Website for contact)

Because of the level of accountability in holding an office, there are REWARDS and CONSEQUENCES when things are not DONE IN ORDER. THE AME DISCIPLINE IS NOT A BOOK OF REPRIMAND! IT IS A BOOK OF ORDER!

"If your brother sins, go and show him his fault in private; if he listens to you, you have won your brother. "But if he does not listen to you, take one or two more with you, so that BY THE MOUTH OF TWO OR THREE WITNESSES EVERY FACT MAY BE CONFIRMED. "If he refuses to listen to them, tell it to the church; and if he refuses to listen even to the church, let him be to you as a Gentile and a tax collector.

-Matthew 18:15-17

### ACCOUNTABILITY OF STEWARD BOARD

- All Stewards are accountable to the Quarterly Conference, which shall be empowered to remove them for failure or refusal to do their duties.
- In the interim of the Quarterly Conference, the Pastor shall have the power to suspend a steward for refusing, neglecting or failing to discharge his duties. The Pastor may fill the vacancy until the next meeting of the Quarterly Conference, which shall dispose of the case.

#### ARMS AND LEGS OF THE STEWARD BOARD

### Stewardess & Deaconess Board

Members of the Stewardess Board are nominated by the pastor and confirmed by the Steward Board.

Stewardesses and Deaconesses assist the Steward Board in the discharge of their duties which includes:

Preparation for the sacraments
Baptism
Holy Communion

### COMMITTEES OF THE STEWARD BOARD (TABLES FOR SERVICE)

- Table of the Minister. The chairperson of this committee is known as the "Pastor's Steward." You are not a junior pro-tem of the board. Your duty is to attend to the welfare of the Pastor. Your committee's efforts reflect the hospitality of the church. You ensure sufficient funds are available for the Pastor's travel. Your primary job as Pastor's Steward is to take care of his/her needs. A Pastor's steward must know his/her responsibilities and never interfere with the duties of the Protem.
- **Table of Lord.** The chairperson of this table (committee) is known as the "Holy Steward." The committee provides for the elements of the Lord's Supper. Generally, the Holy Steward has direct supervision over the stewardesses.
- The Table of the Poor. The chairperson of this committee should furnish the Pastor and Stewards with the names and addresses of the sick and indigent of the church so that pastoral attention and care may be given.

# If we BUILD it, They will PROTECT it!

Mathew 25: 23 King James Version (KJV) His lord said unto him, Well done, good and faithful servant; thou hast been faithful over a few things, I will make thee ruler over many things: enter thou into the joy of thy lord.

#### TRUSTEE BOARD MEMBER MUST...

- Trustees must be nominated by pastor and elected by church conference, at least 18 years of age, and instructed in the duties and responsibilities of the Board of Trustees of the local church.
- The training shall be completed within 60 days after the election, or prior to the appropriate Quarterly Conference, whichever comes first. All Trustees must attend three training sessions. A certificate of Confirmation shall be given to each successful student, to be presented at the appropriate Quarterly Conference, signed by the instructor appointed by the Pastor.
- To be **nominated**, a member must have been a member of a local church at least six (6) months and a member of the African Methodist Episcopal Church for not less than two (2) years, except in case of missions or new work.
- Any person not in good and regular standing in the Church shall be ineligible to be elected a trustee.

#### TRUSTEES...

- Trustees must work harmoniously with the Pastor.
   (Come now, and let us reason together, saith the LORD... Isaiah 1:18)
- Trustees must know the **appropriate** process and procedure for addressing concerns. REFER TO THE AME DISCIPLINE!
- Trustees must pray, not p-r-e-y.
   Protect the interests of the church for the interest of the church!

### **ELECTION OF TRUSTEES**

- Trustees shall be **elected annually** by the members of the church.
- The Pastor shall appoint the time and place for holding the election and give notice of the same from the pulpit at least ten days, including over two consecutive Sundays, previous to the time of election.
- The Pastor shall nominate twice the number of persons to be elected.
- The nominees shall have given written consent for their names to be placed in nomination.
- The Pastor shall declare the results of the election.
- No officer, member or person shall interfere with the election of Trustees or attempt to disturb or prevent the Pastor from holding election. Those in violation of this law are subject to expulsion from the membership.

### THE TRUSTEE BOARD

- The Pastor shall be the chairperson of the Board of Trustees.
- His/her signature shall be required to make the acts of the Trustees legal.
- If the chairperson cannot be present at a meeting, he/she shall appoint a chairperson pro-tem, whose signature also shall be legal.

#### WHAT DO TRUSTEES DO?

Trustees hold responsibility for **the temporal concerns of the church**. They **maintain and secure** all the real and personal property of the church.

#### All church property is held in trust for the AME Church (Connectional).

- Any decisions made by a trustee should benefit, not hinder the church. If the real property deteriorates, the members of the congregation should look to the Trustees.
- Trustees are stewards over the property entrusted to them. Trustees must not only maintain property, but you have an obligation to enhance it.

## WHAT DO TRUSTEES DO?

- Trustees should never allow their church to remain ill equipped.
- Trustees must ensure that the church has the right equipment to make it efficient. If the church can own equipment, why lease? Think about it!
- Trustees must develop a prudent and strong business sense when it comes to the church.

## WHAT DO TRUSTEES DO?

- Trustees must inventory the church and all its property, whether real or personal.
- When leasing property, they must ensure that the rent received is commensurate with the market.
- They must maintain all real property.
- If church property lacks adequate insurance coverage, look to the Trustees. If the church sustains a loss due to undervaluation of its insurance, the Trustees can be held liable.

#### **TRUSTEE BOARD ~ PROCEDURES**

- Whenever improvements are to be made, the Pastor shall call together in a Church Conference the voting members of the church, with a majority vote being necessary for improvements to be authorized.
- When a Church Conference has been properly been called and a majority of the legal voters of the church are not present, the majority vote of those present shall be considered legal.
- Transfer of local church property requires approval by Annual Conference Trustees
- Property can only be sold by approved resolution of Quarterly Conference.

#### **TRUSTEE BOARD COMMITTEES**

- Housing committee address all concerns relating to the parsonage.
- Building and grounds committee -maintenance and upkeep of the church and any other real property owned by the church.
- Personal property of the parsonage and church routinely inventory all personal property owned by the church.
- Insurance responsible for annual review of all insurance for all property (personal/real).

#### **TRUSTEE ACCOUNTABILITY**

- Trustee shall be members of the Quarterly Conference and answerable to that body for their official conduct.
- The Trustees shall make a report of all receipts and expenditures during the quarter to the Quarterly Conference.
- Trustee shall not obstruct or interfere in any church.

### **TRUSTEE ACCOUNTABILITY –**

- They shall not prevent or attempt to prevent the bishop or ministers of the African Methodist Episcopal Church from preaching, expounding God's Holy Word, or serving as Pastor.
- They shall not prevent or attempt to prevent the use of the property for religious services or proper activities held from time to time which are recognized by the Annual or General Conference, or by the duly appointed presiding bishop under whose jurisdiction the Pastor is stationed.

Because of the level of accountability in holding an office, there are REWARDS and CONSEQUENCES when things are not DONE IN ORDER. THE AME DISCIPLINE IS NOT A BOOK OF REPRIMAND! IT IS A BOOK OF ORDER!

"If your brother sins, go and show him his fault in private; if he listens to you, you have won your brother. "But if he does not listen to you, take one or two more with you, so that BY THE MOUTH OF TWO OR THREE WITNESSES EVERY FACT MAY BE CONFIRMED. "If he refuses to listen to them, tell it to the church; and if he refuses to listen even to the church, let him be to you as a Gentile and a tax collector.

#### **TRUSTEE ACCOUNTABILITY**

- Any trustee ceasing to be a member of the denomination, by reason of expulsion or otherwise, shall immediately cease to be a trustee
   EXCEPT IN CASES OF DEBT for which he/she is joint security.
- In such cases, termination as a trustee will occur when the creditors have been satisfied.

#### **TRUSTEE ACCOUNTABILITY**

- In the interim of a Quarterly Conference, the pastor shall have the power to suspend a trustee who refuses, neglects, or fails to discharge his/her duty.
- The Pastor can fill the vacancy temporarily in the manner prescribed in the selection of a trustee until the next meeting of the Quarterly Conference, which shall dispose of the case.
- Should the suspension be sustained by the Quarterly Conference, the Pastor shall proceed to fill the vacancy permanently, following the usual mode of election of a trustee.

#### "ROLE OF LAITY IN HEALTHY, GROWING AND RELEVANT CHURCHES"

Too many lay persons are in positions for which they have not been trained or prepared. You cannot blame people for not doing what they don't know to do. There must be a partnership between clergy and laity if our churches are going to be healthy.

## LAITY IN A GROWING HEALTHY CHURCH...

There are a number of characteristics which determine whether a church is healthy. There is no one absolute list, but there are some characteristics which are common to every healthy church.

- I. God's Empowering Presence
- 2. Impacting Worship
- 3. Commitment to Prayer and Study of God's Word
- 4. Making Disciples
- 5. Spiritual Discipline and Passion for the Things of God
- 6. Loving and Caring Relationships
- 7. Servant Leadership Development
- 8. Administration and Accountability
- 9. Ministry to Church and Community
- 0. Stewardship and Generosity

#### A HEALTHY CHURCH? WHAT CAN ORGANIZED LAY DO?

- I. Be empowered by the Holy Spirit at work in their lives. Church can do nothing without the Holy Spirit.
- 2. Each lay person must make a personal commitment to be spiritually healthy themselves. If a church is not healthy it is because those who make up the congregation are not healthy.
- 3. Good leadership develops other leaders. The pastor must not be the only leader in the church.
- 4. There must be effective administration and accountability
- 5. Church must be engaged in ministry to church and community
- 6. Congregation must exercise good stewardship and be generous in their giving The Book of Acts describes a healthy church. (Acts 2:42-47)

### DOES YOUR CHURCH HAVE... A MISSION? A VISION?

Mission statement not only says what the church does, but also lets us know what the church doesn't do.

The vision statement is aspirational, and says what the church intends or seeks to become.

Mission and vision come from God to the pastor. Church can only have one vision. Must be presented to and embraced by congregation. Printed in bulletin weekly, taught to congregation, new members class, organizations, etc...

#### SAMPLE MISSION AND VISION STATEMENT

The mission of \_\_\_\_\_\_ church is to worship and praise God with joy, passionately proclaim and teach His Word, eagerly seek to win and make disciples for the Lord Jesus Christ, who will join with us in ministry, mission and outreach."

The vision of \_\_\_\_\_\_ is to become Disciples of Christ, who know Him and make Him known, and passionately promote His kingdom in this community and beyond.

## WHO ARE MEMBERS OF THE LAY ORGANIZATION?

Station or Circuit Lay Organization

- The pastor of each Station or Circuit shall, within thirty (30) days after the Annual Conference, call a meeting of the members of the Charge for the purpose or organizing a Lay Organization where none exists.
- The Station or Circuit Lay Organization shall be composed of all members of said Station or Circuit who desire to enroll.
- The officers of the organization shall be elected from those enrolled in said organization.
- The President of the Lay Organization, or a duly elected representative of the local church, becomes a member of the Official Board by virtue of office.

The Lay Organization promotes the support and participation of laity in the various programs of the church.

The Lay Organization is also responsible for conducting recurrent study and stimulating education of laypersons with regard to the laws and guidelines listed in the Discipline of the African Methodist Episcopal Church.

- Attend church regularly, tithe, and attend Bible study and Sunday school if you intend to be a steward or trustee. You must be active in the life of the church.




